## Analysis of Language Error at Morphological Level on *Covesia.Com* Online News Portal

### Abstract

This study took three samples of article titles: Talempong Batu and the Mystery of the Lost Tuanku Nan in Limapuluh Kota District, April 19, 2022 edition, West Sumatra Consultants Association, Strengthening Alignment with the Use of Regional Products, May 21, 2022 edition, and the Padang Adityawarman Museum Exhibits Gold and Silver Jewelry from Minangkabau and Yogyakarta, 28 October 2022 edition. This study aims to analyze the appropriate use of language. The stages used in data collection in this study are, first, data collection from data sources by reading and recording. Both data analysis and correction efforts. The final stage is drawing conclusions. The technique used by the author in analyzing the data is by reading and writing techniques, meaning that every data obtained is read carefully then written errors in the language of morphology in the field of morphology and corrections are also written. The method used in this research is descriptive qualitative research. The results of this study are the analysis of language errors at the morphological level including: (a) errors in using affixation, (b) writing standard words, (c) affixation that does not melt, (d) compound words, (e) reduplication process.

### Introduction

Online news portals are news available via the internet via a website or application. In this day and age, online news portals are very easy to access by all groups. According to Juditha (in Faradilla, 2021) states that the existence of the internet which is able to provide various kinds of information and news is gradually starting to surpass the popularity of print media. The purpose of writing news is to provide information based on clear facts to readers so that when writing news, you must pay attention to language rules. This is because news is writing that is able to influence readers. By paying attention to good and correct writing on online news, it can indirectly become an influence so that people can understand writing and the rules for writing Indonesian according to the established rules. However, without realizing it, the language errors used by online news portals are followed by the public. Therefore analysis of language errors in news portals, especially online news, is very important to do.

Analysis of language errors is an activity carried out to collect, analyze, explain, classify errors, and evaluate language errors. According to Samsuri (in Mutolib, 2022) the purpose of analyzing language deviations is to understand spoken, written, structured and functional language. Language errors are the use of Indonesian both orally and in writing that are outside or deviate from communication factors and linguistic rules in Indonesian (Tarigan, 2012). Language errors can also be interpreted as the use of language that is not in accordance with the linguistic rules that apply in the language itself. From research that was conducted by Abdul Mutolib (2020) with the title "Analysis of Language Errors at the Morphological Level in Demonstran.Com Online Media, News Recapitulation and Determination of the 2020 Kediri Regency Election Results", states that the errors that often occur in online media are at the morphological level. This is because morphology is related to words and parts of words. Forms of errors

at the morphological level include (a) errors in the use of affixes, (b) writing standard words, (c) affixes that do not blend, (d) compound words, (e) reduplication processes.

Morphology is important in the study of language use because morphology is the basis of the formation of words, clauses, phrases, to the level of sentence formation. Etymologically, the word morphology comes from the word morph which means form and the word logy which means science. So, literally the word morphology means the science of form. According to Ramlan (in Chaer, 2008) morphology is part of linguistics (lingua) which studies word forms, changes in word forms, changes in word forms to meaning and word groups. Therefore, morphology is an important study in the analysis of language errors (Chaer, 2008).

In this study, the authors chose the online news portal *Covesia.com*. This is of course very unfortunate if there are still writing errors at the morphological level. The purpose of this study is to analyze the appropriate use of language. This research analyzes errors at the morphological level which include, (a) errors in the use of affixes, (b) writing standard words, (c) affixations that do not melt, (d) compound words, (e) reduplication processes.

## **Methods**

In analyzing language errors on the *covesia.com* online news portal, the method used in this research is descriptive qualitative research. It is said to be descriptive because this study describes the data to be analyzed in the form of morphological level errors found on the online news portal *covesia.com*. The data in this study took three samples of article titles, namely: Talempong Batu dan Misteri Tuangku Nan Hilang di Kabupaten Limapuluh Kota issue of 19 April 2022, Ikatan Konsultan Sumbar, Perkuat Keberpihakan Pemakaian Produk Daerah issue of 21 May 2022, and Museum Adityawarman Padang Pamerkan Perhiasan Emas dan Perak dari Minangkabau dan Yogyakarta issue of 28 October 2022.

The stages used in collecting data in this study were, firstly, collecting data from data sources by reading and recording them. Second, data analysis and correction efforts. The technique used by the author in analyzing the data is by reading and writing techniques, meaning that every data obtained is read carefully then written down language errors in the field of morphology and also written down corrections. The data is presented in tabular form with any errors which are analyzed in detail. The final stage is drawing conclusions. Conclusions are conveyed to answer the formulation of the problem formulated at the beginning of the study.

## **Results and Discussion**

Based on data collection conducted by the author regarding the analysis of language errors at the morphological level on the online news portal *Covesia.com*. In speaking, not everyone knows how to use language properly and correctly, because basically everyone has different competencies. This of course depends on the habits of yourself. When a child is used to using language properly and correctly, naturally the child will transfer his habits to another place. However, if the environment has an adverse impact on the language, then it will most likely have an impact on the child. This has to do with morphology. Morphology is the study of the form and formation of words. In this article, the analysis of language errors in morphology is an activity to analyze errors regarding the formation of words that deviate from Indonesian grammar rules.

There are many errors in writing due to writing errors, the use of sentence structures and the editor's escape in the process of editing the manuscript, there are many errors in typing, and the use of spaces must also be considered in using good and correct language. In this research article, the author discusses the writing and wording techniques used in this study. The language error analysis discussed in this article is:

- 1) Errors in the use of affixes, including the addition of spelling or conjunctions that are considered inappropriate and not in accordance with the specified spelling.
- 2) Writing standard words, which includes spelling errors, words that are not suitable and the use of words that are not appropriate.

- 3) Affixation that doesn't melt, where the affixes that are added are not suitable so that the reading becomes wrong and not in accordance with the rules of the Indonesian language.
- 4) Compound words, including writing errors that are separated or combined which should be in accordance with the correct Indonesian spelling.
- 5) The process of reduplication, where reduplication is a repetition of a grammatical unit, either in whole or in part, whether with phoneme variations or not..

The following is an analysis of language errors at the morphological level that has been carried out by the author on the online news portal *Covesia.com*. The following is an explanation regarding the analysis of language errors that have been carried out.

### ***Misuse of Affixation***

Errors in the category of writing errors using affixation on the online news portal *Covesia.com*, found twelve errors using affixation from three news titles. Errors in the use of affixes in the online news portal *Covesia.com* which have been analyzed show that most errors are due to typos made by the author in the affixation section. The following table shows an analysis of errors in the use of affixes in the online news portal *Covesia.com* that have been found.

Errors in writing the category of errors in the use of affixes on the online news portal *Covesia.com*, found errors in the use of affixes that do not merge from three news titles. The following table shows an analysis of errors in the use of non-melting affixes found on the *Covesia.com* online news portal.

### **Use of Compound Words**

Error in the category of writing compound words on the *Covesia.com* online news portal. In this category, one compound word writing error was found from three news headlines. The following is a table of errors in writing compound words in the online news portal *Covesia.com* that have been found.

In this sentence there is an error in the use of compound sentences. Sentences on news headlines “Talempong Batu dan Misteri Tuangku Nan Hilang di Kabupaten Limapuluh Kota” on the online news portal *Covesia.com* it is not quite right, the news says the word “Limapuluh Kota” combined words lima and puluh, must be written separately in accordance with the rules of the Indonesian language. ### 1. Rectification:

In this sentence there is an error in the use of reduplication. Sentences on news headlines "Talempong Batu dan Misteri Tuangku Nan Hilang di Kabupaten Limapuluh Kota" on the online news portal *Covesia.com* it is not quite right, the news says the word "berturut turut" do not use hyphens, must be written "berturut-turut". There is the addition of a hyphen, to connect two words.

## Conclusion

Based on the results of the research analysis that has been analyzed, it can be concluded that there are still many errors found in every word in the online news portal *Covesia.com*. Errors occurred in the field of morphology and EBI including errors in the use of affixes, errors in writing standard words, errors in the use of affixes that do not melt, errors in the use of compound words, and errors in the use of reduplication. Many of these errors are motivated by writing errors, the use of sentence structure and the editor's escape in the process of editing the manuscript, many errors in typing are found, and the use of spaces must also be considered in the use of good and correct language. In the study entitled "Analysis of Language Errors at the Morphological Level on the *Covesia.com* Online Portal" a number of five types of errors were found at the morphological level totaling 23 data findings, namely types of affixation errors, affixation that does not dissolve compounding, standard words and reduplication. From these studies, the most frequently encountered, namely affixation errors.

Therefore, it is better if the writer is more thorough and understands the concept of writing and the concept of good language. In addition to making it easy for readers to understand, writing also needs to be considered to maintain language rules and standards. The editor must work more thoroughly and understand well the existing language rules. Through this understanding, it will have a positive impact on the ongoing quality of articles taking into account the context and writing.
